






LED is recommended for reflow soldering and soldering profile is shown below.

Notes


- 1. Maximum soldering temperature should not exceed 260°C $\,$







Remarks:

- 2. Luminous intensity / luminous flux: +/-15%
- 3. Forward Voltage: +/-0.1V






